## Cody Gate Ventures Bringing 250 Full-Time Jobs To Rochester, N.Y.

Cody Gate Ventures, a venture capital firm, has selected Rochester, N.Y. as the site of expansion for three companies that are part of its portfolio. The three companies are Intrinsiq Materials, Quintel Technology, and Omni-ID. They will combine to hire 250 full-time employees who will specialize in research, development, and manufacturing of advanced technology. In addition to creating jobs, Intrinsiq, Quintel and Omni-ID will also make a significant capital investment in the Rochester Region through the purchase of machinery and equipment, and through ongoing capital expenditures and operating expenses.

"We chose to expand in Rochester because of the high-quality of its skilled workforce," said Cody Gate Ventures U.S. Managing Partner Michael Summers. "We consider ourselves to be an innovation firm, and Rochester has a long history of innovation. We have already established substantive synergies with a number of the great companies and universities that are located here. Those opportunities for collaboration combined with Rochester's connectivity to world-class research and development facilities, and the great facilities at Eastman Business Park, make the Rochester Region the perfect place for these three companies to grow."

"This huge win for the Greater Rochester Region's economy is the result of the dedication and teamwork of Greater Rochester Enterprise; Empire State Development; the State of New York, specifically State Assembly Speaker Sheldon Silver and State Assemblyman Joseph D. Morelle; Monroe County; and the City of Rochester," said GRE President and CEO Mark S. Peterson. "The 250 jobs that are coming here are high-paying (\$87,000 per year average salary), highly-skilled jobs for three companies who will greatly benefit from our top-ranked knowledge workforce."

"Attracting innovative companies that base their success on knowledge and technology is an important step in ensuring that New York State remains competitive in the global economy," said Empire State Development Chairman & CEO Dennis M. Mullen. "Cody Gate Ventures has discovered that Rochester offers an ideal location—strong public and private institutions, a quality talent pool and widespread infrastructure—for companies looking to expand their horizons."

"Monroe County's highly-skilled workforce, rich tradition of innovation, and intellectual capital are some of our most significant assets and the rest of the world is beginning to realize what we've known all along," said Monroe County Executive Maggie Brooks. "This project represents a great deal of investment in our community and the addition of 250 jobs for local residents will contribute greatly to the economic vitality and strength of our economy. COMIDA is a proud partner in this project and we thank these companies for their commitment to doing business in Monroe County."

"The City and County have a common goal to attract business development within the Rochester community and we are making great progress," said Mayor Duffy. "With at least two of the companies anticipated to be on the city portion of the site and one being in Greece, it was crucial for us to work together. The County Executive and I would especially like to thank our business development teams for the tremendous work they performed to make this project a reality."

Intrinsiq Materials ([www.intrinsiqmaterials.com](http://www.intrinsiqmaterials.com)), an advanced materials company that produces designer materials that make other products more effective, plans to hire 158 full-time employees. Quintel Technology ([www.quintelsolutions.com](http://www.quintelsolutions.com)), an advanced antenna company that wireless carriers like AT&T use to more efficiently transmit signals, plans to hire 68 full-time employees. Omni-ID ([www.omni-id.com](http://www.omni-id.com)), a producer of radio frequency identification tags that track and identify different assets and materials, plans to hire 24 full-time employees.

Intrinsiq, Quintel, and Omni-ID plan to begin hiring and bringing their operations to Rochester this summer. More information on how to apply for these new jobs is available at each of the company's websites.

# Harris RF Communications Strengthens Presence in Greater Rochester Region

Harris RF Communications has been contributing to the strength and vitality of the local economy for 50 years, employing more than 2,300 local residents. Harris is an international communications and information technology company that supplies secure voice and data communications products, systems, and networks to military, government and commercial organizations worldwide.

While recently evaluating excess capacity in its out-of-state facilities, Harris contemplated moving its manufacturing operations to either Melbourne, Florida or Lynchburg, Virginia. Faced with the prospect of

losing 1,100 highly-skilled manufacturing jobs, the Greater Rochester Region worked with the strong leadership at Harris to ensure its continued presence and investment in the local economy.

In a collaborative effort, the County of Monroe Industrial Development Agency (COMIDA) and Empire State Development (ESD) worked with Harris to develop an incentives package that represents an almost \$50 million investment in the local economy.

Harris purchased the former Xerox Corporation facility in Monroe County. This 573,000-square-foot building

allows Harris to condense its local manufacturing operations to one location, rather than the four separate facilities currently being operated. The relocation is expected to be complete in the summer of 2011.

Harris' decision to remain in Monroe County speaks volumes about the Greater Rochester Region's significant assets, including its highly-skilled workforce. The region's large pool of colleges and universities assists Harris RF Communications in cultivating its workforce of tomorrow.

## CanAm Wind Energy Initiative Looks to Capitalize on New Energy Opportunities

The CanAm Wind Energy initiative, a formal partnership between Greater Rochester Enterprise (GRE), Buffalo Niagara Enterprise (BNE), and Niagara Economic Development Corporation (NEDC) Canada, officially launched in May. The three organizations have partnered to capitalize on the rapidly growing wind energy industry, which is expected to generate \$60.8 billion in revenue by 2016. With the bi-national Rochester, Buffalo, and Niagara regions emerging as a top location for wind farm development, CanAm Wind Energy's aim is to create more jobs and further diversify and strengthen the regional economies through new energy opportunities.

"In today's competitive economic environment, regional collaboration is key to economic success," said GRE President and CEO Mark Peterson. "Through this partnership, the Greater Rochester, Buffalo, and Niagara Canada regions will be in a better position to compete globally for jobs and investment."

CanAm Wind Energy will work with government leaders, businesses, universities and other not-for-profit economic development groups to ensure a united approach to attracting the wind industry.

The effort will include promoting the bi-national region, connecting businesses with resources in the bi-national region, and leading appropriate initiatives to increase resources for new and established businesses.

CanAm Wind Energy made its debut at the world's largest annual event for wind energy, the 2010 Wind Power Conference and Exhibition. The conference took place from May 23-26 in Dallas, TX.
